Our specially trained teams provide over 5 thousand hours of volunteer service a year(an equivalent of over \$120,700 of donated time)in hospitals and healthcare settings, mental health settings, shelters, schools, libraries, universities, courts, and the Salt Lake Airport. In addition, UPP provides public education concerning the benefits of the human-animal bond in specific presentations, engages in research and special partnerships with educational institutions and human health professionals to explore the potential of animal-assisted therapy, and participates in workplace wellness events for a variety of high-stress businesses.
